Said insurance must cover injury and/or damage incurred in connection with the event. Upon request, I will provide satisfactory evidence of said insurance. I certify that training compliant with the Youth Safe Sports Act of 2017 has been made available to me this year if I am participating in a youth event. I hereby wave my rights of privacy or publicity with regard to the unconditional right to use my name, voice, photographic likeness, video and biographical information and fishing tips and instructions in connection with any reproduction of same, video\audio productions and\or articles and press releases by the event organizers, their parent or affiliate companies, and those acting under their permission, anywhere at any time, through any medium or media. I shall not be entitled to receive any royalties or other compensation in connection with such use. I further understand and agree that the tournament officials reserve the right to reject my application for any reason whatsoever. #### TOURNAMENT RULES

#### **Open Tournament On the Chickahominy River**

Tournament launch will take place at the fishing pier near the Rte 5 bridge. Launch will be in a single file by launch order. You must pass by the end of the dock with live wells open, life jackets on and zipped with kill switch attached and lights must be on. If any of these situations are not correct when passing the Tournament Director on the end of the dock you will be sent to the back of the line of that flight. The First Flight (boats 1-25) leaves at 6:00 AM (or safe light) and returns at 3:00 PM. Each 25 boat flight will return 15 minutes after the previous flight (for example 2<sup>nd</sup> flight weigh-in will be at 3:15 PM, 3<sup>rd</sup> flight will weigh-in at 3:30 PM, etc.). The <u>WEIGH-IN</u> will be conducted at the Riverfront Park designated Tournament Weigh-in Area. The area will be well marked. Prior to weigh-in, anglers <u>must</u> check in with a Tournament Official, who will be located in Gordon's Creek near the fish release pipe. Boats will be trailered prior weigh-in of your fish. Please hold your fish until the Tournament Director has opened the scales. IN AN EFFORT REDUCE THE STRESS ON THE FISH BY EXTENDED WAITING IN LINE PLEASE USE ONLY THE REGION 8 BAGS PROVIDED FOR WEIGH-IN!! Tournament awards/pavout will be conducted at the weigh-in site.

Boats must be at least 14 feet or more in length and powered by at least a 9.9 HP engine. An operating live well is required. Co-Angler will verify the ignition kill switch is operating properly prior to blast off.
Live-wells will be open and inspected by Tournament Officials when they pass by the dock at Blast off.

**3. OFF LIMITS AREAS** – any water or areas designated by the tournament officials or posted as Off Limits, No Fishing, or No Boats by Local, State or Federal agencies is Off Limits. Chickahominy Lake is Off Limits. No boats are allowed within 100 feet above or below Walkers Dam.

**4.** Life Jackets must be worn and zipped anytime the gasoline engine is in gear. Results for not following This rule will be disqualification from the tournament.

**5.** Kill switch must be attached to the boat operator anytime the gasoline engine is in gear. Co-Angler MUST verify proper operation of the engine kill switch prior to tournament launch.

6. Running lights on your boat must be in place and on in the morning.

7. Creel and length will be 5 bass per boat. All fish at least 12 inches in length.

8. Dead fish penalty will be 4 oz (.25lb) per dead fish.

9. Short fish penalty: Short fish will not be weighed plus a 1 Lbs penalty.

10. Bringing more than 5 fish to the dock will result in a disqualification, i.e., no culling or measuring of

fish is permitted at the dock. No fishing after you have checked in.

**11.** You cannot cull dead fish large enough for scoring.

**12.** Alcohol will not be permitted in your boat at any time or at the weigh in site.

**13.** You cannot fish within 50 yards of an anchored boat and when the trolling motor is out of the water.

**14.** Live or natural baits are prohibited. Trolling is not allowed.

**15.** You cannot leave your boat or come in contact with another boat unless it is an emergency or a breakdown. Bathroom breaks are allowed.

**16.** Every boat must check in at the check in site even if you will not weigh in fish.

**17.** If you check in late, a 1 lb per minute penalty will be assessed for the first 15 minutes. After 15 minutes there will be no weight posted. The Check-in Official will let you know if you are late.

**18.** Communication devices may not be used for the purpose of locating or catching fish.

**19.** If for any reason you choose to leave the tournament and return home, please notify a tournament official first.

**20.** If a tie exists, payout for tied weights will be computed by adding payout values for tied positions then divided equally between tied anglers/teams.

**21.** Protests can be made at any time during the tournament to the Tournament Committee/Official or within 15 minutes after arrival at the check in site, followed by a written protest within 10 minutes after closing the scales. The Tournament Director's decision is final.

**22.** Polygraph examinations may be made if the Tournament Committee deems it necessary. Participation in the Tournament implies consent and agreement to a polygraph examination.

**23.** Any participant issued a citation by a law enforcement officer will be disqualified.

24. Emergencies or breakdowns: Every boat must be checked in and accounted for at the end of the
